## **CONDITIONS OF ENTRY**

## PLEASE READ THIS AND THE EXHIBITORS GUIDE BEFORE SIGNING YOUR ENTRY FORM

- 1. Entries/exhibits must be presented in a complete and safe working condition. Consumption of alcohol during the hours the show is open is forbidden.
- 2. All entries/exhibits must be insured for a minimum third party risk and road vehicles must be fully licensed (where applicable) and tested in accordance with existing construction and use regulations for the class of vehicle. Please have your insurance certificate with you, we may ask to inspect it.
- 3. Owners must ensure that all drivers are fully competent and permitted by law (licensed and insured) to operate the vehicle. Unlicensed drivers, especially children, are not permitted to drive any vehicle, quad bike or mini-motorcycle (however powered) on the Airfield or its environs. Please remember that ALL the roads on and around the Airfield are Public Highway and all vehicles and drivers MUST be licensed and fully insured.
- 4. No exhibit may be left running unattended & all exhibits must be securely braked or chocked.
- 5. FUEL will not be transferred on the site on any permeable surface. Engine drip trays to be used where necessary.
- **6.** Exhibitors will not move any vehicle in the show area during public opening times without the prior permission of the event organisers or their officers. We recommend motor cyclists should wear approved crash helmets.
- 7. At the close of each day, please take care and be aware of children and pedestrians at all times when leaving the area.
- **8.** No additional vehicle may be brought onto the site without prior permission. Free vehicle parking is available in the public car park nearby. All civilian support vehicles must be parked in the public car park. Please ensure any vehicle not part of your display or trade stand is moved off the show area by 9.30am each morning.
- **9.** Exhibitors and their parties must pay full regard to event officials/marshals instructions and conduct themselves in a manner which will not inconvenience or endanger any persons at any time.
- **10.** CAMPING: If you wish to camp overnight, please contact us for further information.
- **11.** WEAPONS No weapons are to be discharged or carried on site except by prior arrangement with the organisers. Edged weapons must remain sheathed at all times (no exceptions). Deactivated weapons must be accompanied by a valid deactivation certificate. Live weapons and live ammunition are not permitted.
- **12.** The use of any pyrotechnics is prohibited. ANYONE FAILING TO OBSERVE THIS RULE WILL BE ASKED TO LEAVE IMMEDIATELY
- **13.** LITTER Exhibitors/Traders are expected to maintain their area and the ground adjacent to it in a clean and tidy condition. **Please ensure you take all your rubbish away with you and nothing is left on site.**
